## **End User License Agreement** **for the products delivered by <https://octoplug.xyz/> under a commercial license**

This End User License Agreement (EULA) is a legal agreement between you (either an individual or a single entity) and the Owners (Julien Silvestre, Jason Mertens and Alexandre Edde) of this Software for ooVfxArnoldTools identified above, which includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("ooVfxArnoldTools").

By installing, copying, or otherwise using ooVfxArnoldTools, you agree to be bounded by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use ooVfxArnoldTools.

### **1. Grant of License.**

You may not reverse engineer, decompile, or disassemble ooVfxArnoldTools, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.
